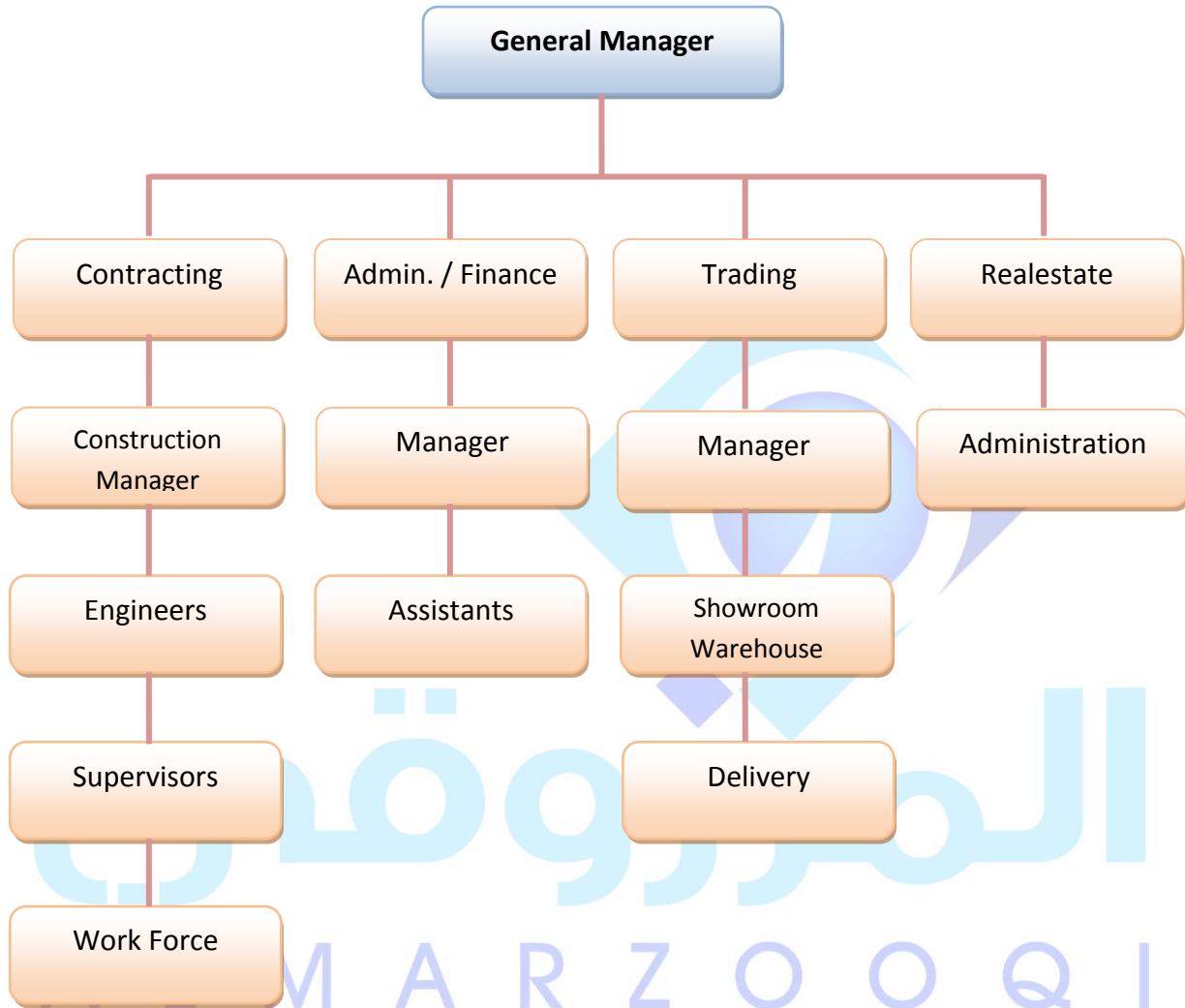

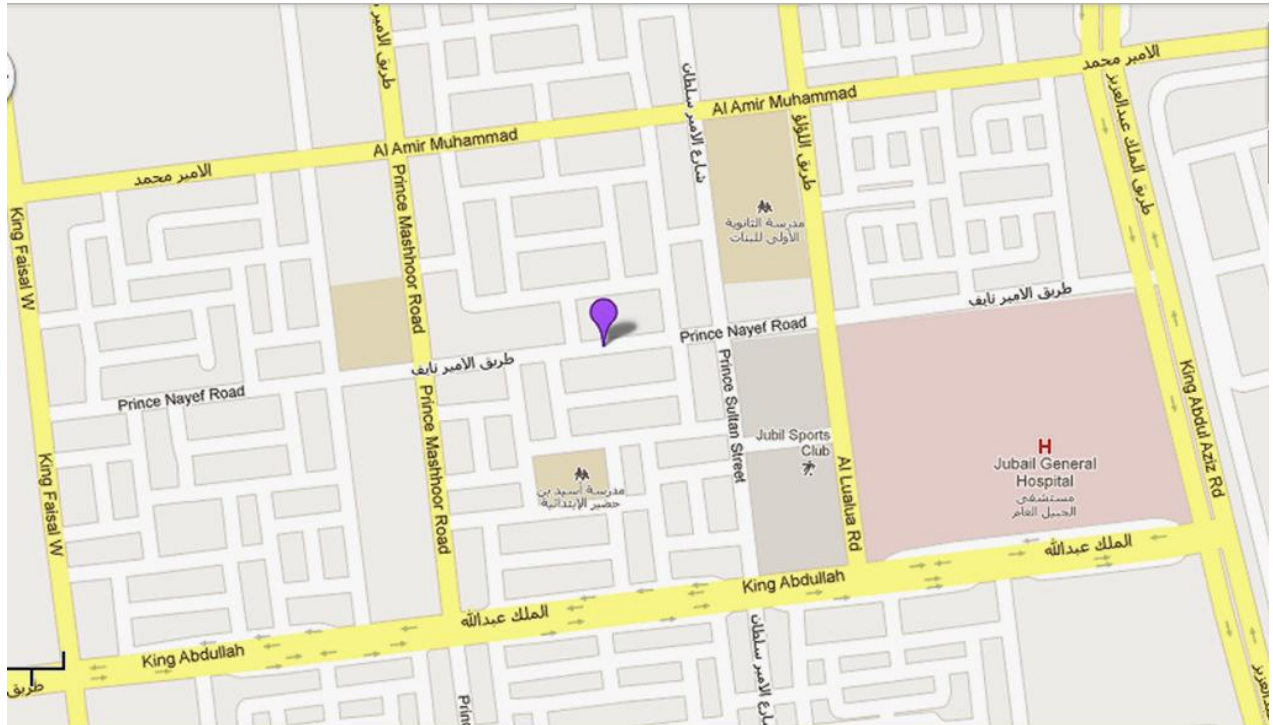
ORGANIZATION CHART
